

Subject: Bill Payment Methods for HOME AND COMMUNITY CARE LTD, SAJIDA Foundation

Dear Sir/Madam,

Greetings from Home and Community Care LTD, (previously known as Elder Care)

This is to inform you about the available payment systems of HCCL. We accept payment through the following methods for collecting security deposits and monthly service bills:

- 01. Via account payee cheque made to the name of "HOME AND COMMUNITY CARE LTD", BRAC Bank, A/C No. 1526204432008001
- 02. Via direct cash deposit to the aforementioned account "HOME AND COMMUNITY CARE LTD", through any branch of BRAC Bank. For cash deposit, a deposit slip along with the name and IDof the client must be emailed to hccl@sajida.org
- 03. Via direct/online transfer (EFTN) to the aforementioned account "HOME AND COMMUNITY CARE LTD". Beneficiary bank's branch name would be North Gulshan Branch. For direct/online transfer, the transfer confirmation SMS/email or a photo proof along with the full name & ID of the client should be emailed to https://doi.org/ncb/hcm2
- 04. In case of Remittance payment or any other payment which includes VAT/TAX or any other charges applicable, will be borne by the client. If any charges already applied to the paid amount, then net received amount will be accounted as collection and adjusted with the receivable. If any due remains that will proceed to add with the next month's invoice or in case of service discontinuation due amount will be adjusted with the deposited security deposit or advance amount.

Note: Please be informed any direct Cash payment to HCCL is strongly discouraged. If you wish to transfer money internationally, please provide your respective foreign Bank with the following information. And also feel free to contact us through email if the bank in your country requires any further information.




